Conservation Element Discussion

- 3. Question to group; Support, encourage or promote which is better, which would we like to see in the future? Referring to "Encourage" question.
- 4. I don't want to see more restaurants, shops or living spaces. I would like to see tech jobs, or the area become a center for something; Marijuana, breweries, etc. Referring to "Costco" area, Rose Creek Canyon re-development of industrial area.
- 5. Make zoning flexible to allow for residential development neat trolley lines.
- 6. Participant suggested that we remove this language from the current CPU and that we remove all fencing from the SDG&E yard for better views.
- 7. Why are we going to landscape, wall or cover the SDG&E yard? Participant was reminded that this was already in the 1989 CPU.
- 8. Use SDG&E yard for recreation.
- 9. (Friends of Forrest Creek) Use Rose Canyon for recreation, tie elements together, bowling alley, Trampoline Park.
- 10. Remove SDG&E fencing for better views.
- 11. How do we capture ideas from our meeting? Can we have a matrix (of big ideas)?
- 12. How do we release topics prior to meetings?
- 13. When will we address zoning and planning issues?
- 14. Why does it take so long to implement the approved ideas/plans? Referring to 2020
- 15. Who fixes the infrastructure between now and 2020 (while the projects are finished)?
